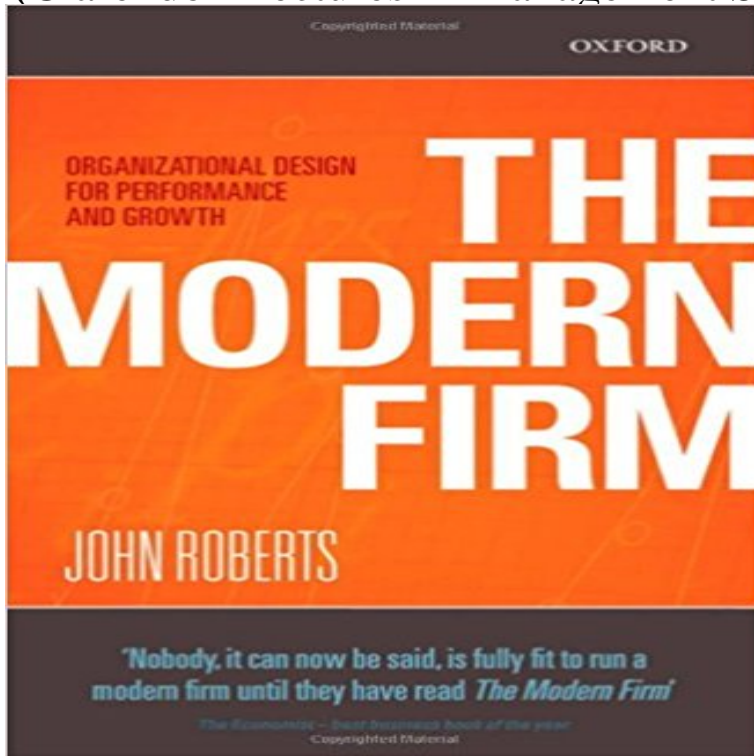


The Modern Firm: Organizational Design for Performance and Growth (Clarendon Lectures in Management Studies)
