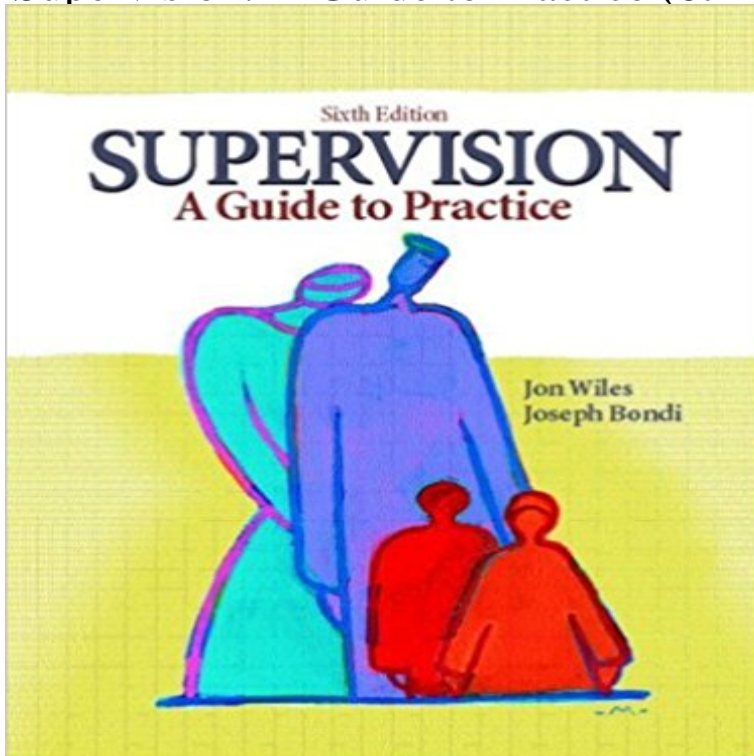


## Supervision: A Guide to Practice (6th Edition)
