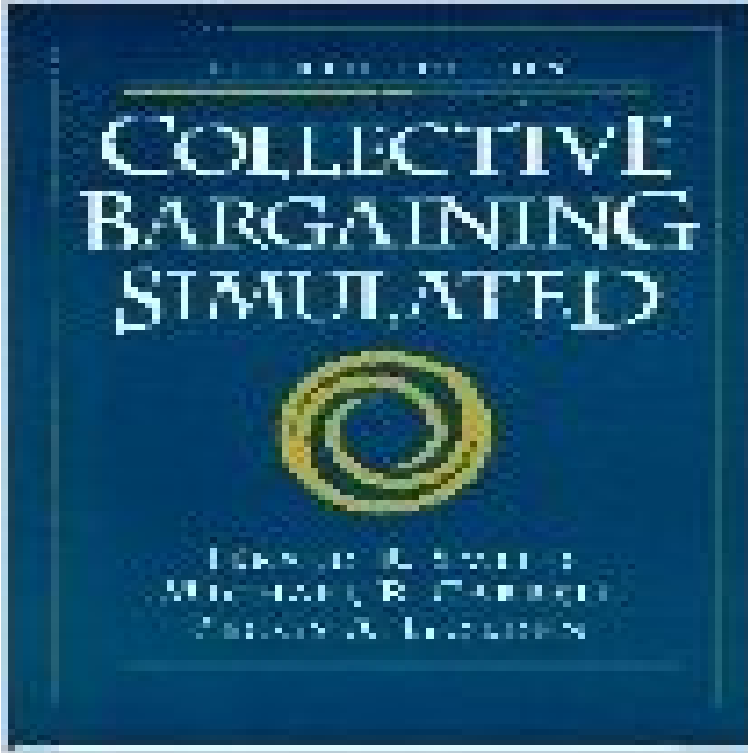


Collective Bargaining Simulated (4th Edition)

Users must consider issues such as financial elements, wages, overtime, sub-contracting, drug testing, profit sharing, and health and pension benefits. Variables in the simulation reflect current trends in bargaining agreements such as wages, job titles, etc.
