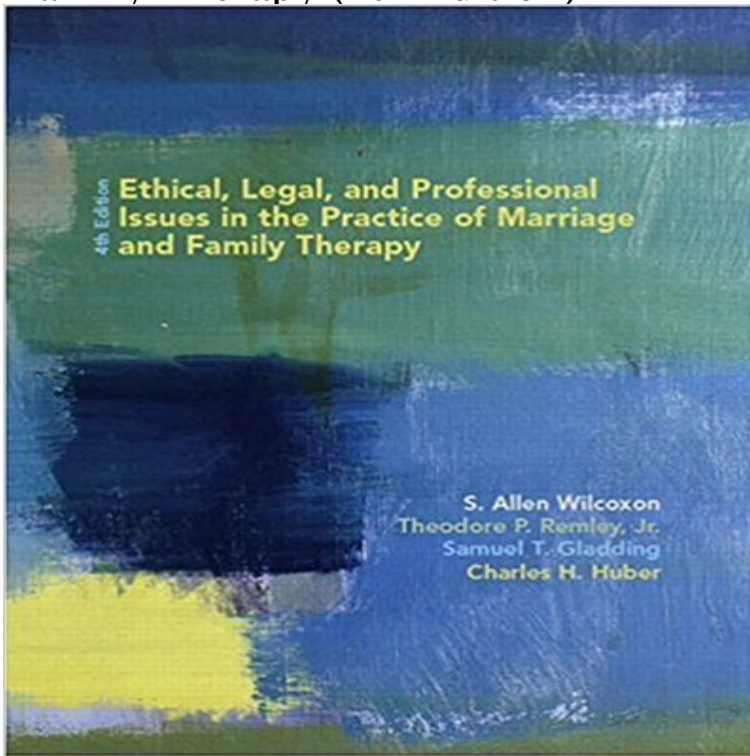


Ethical, Legal, and Professional Issues in the Practice of Marriage and Family Therapy (4th Edition)
