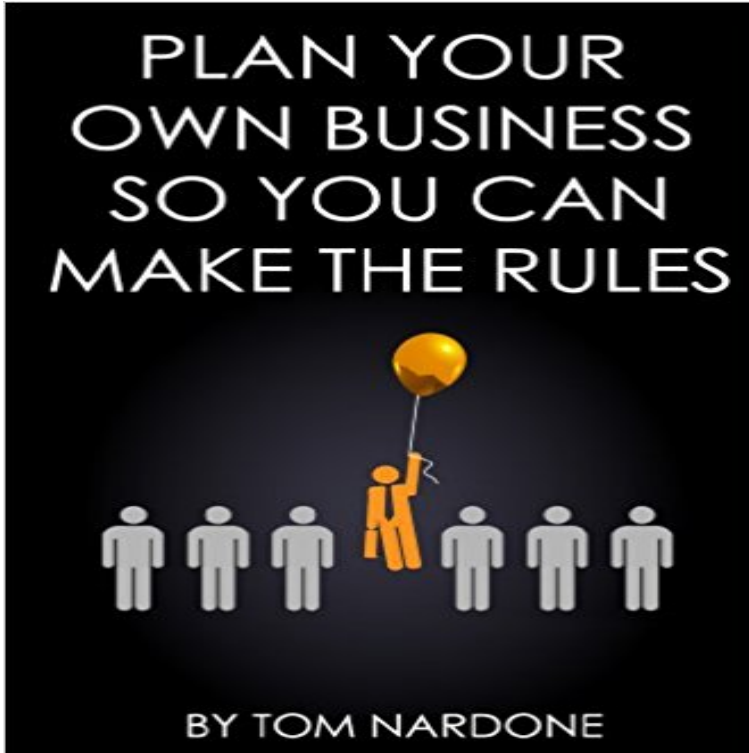


# Plan Your Own Business So You Can Make The Rules
