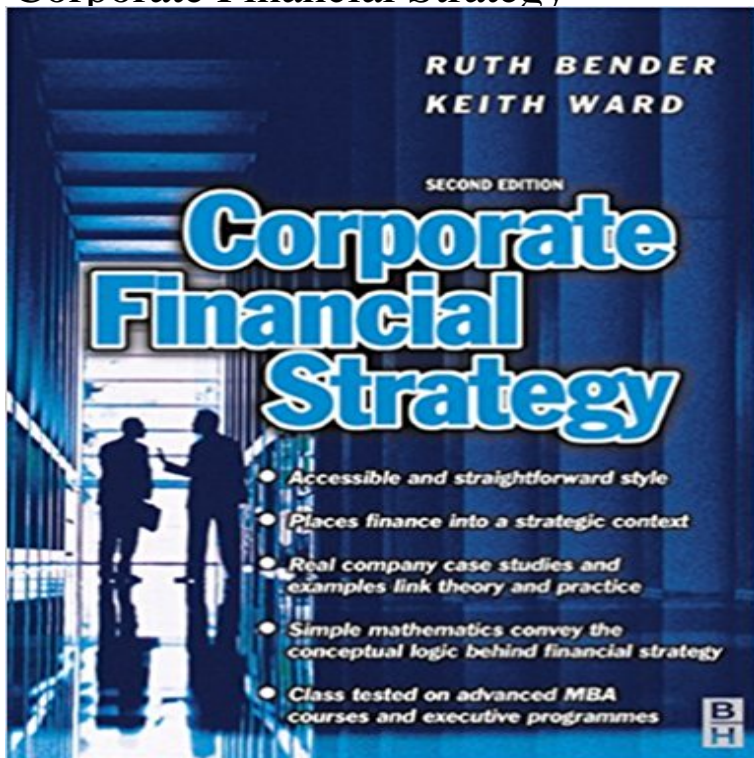


# Corporate Financial Strategy
